Superintendent's Evaluation

Former School Committee member Stephen Udden joined the committee for the superintendent's evaluation portion of the meeting. Ms. Belanger read the superintendent's composite evaluation for the 2015-2016 school year in its entirety, including the framework for the evaluation, progress toward established goals, performance against four state determined standards, and overall summative performance. Of the five committee members who participated in the evaluation, two members found the superintendent's overall performance to be "Proficient," while three members rated her performance "Exemplary." Ms. Spinelli thanked those who participated in the evaluation process and noted she appreciates the feedback. Ms. Belanger announced that a 2-year extension through June 30, 2019 has been approved for the superintendent's contract. A 3% salary increase was also approved for the 2016-2017 school year (\$186,558).

Ms. Belanger noted that she consulted with the school attorney regarding drafting a resolution regarding charter school expansion. He advised against drafting or submitting such a proposal as a committee.
